## SPEAKERS AND WORKSHOP LEADERS



**Dr Joseph Mutei** (BD, MA, Ph.D.) is the Dean – of Students Affairs and Senior Lecturer at St. Paul’s University, Kenya. Dr. Mutei teaches in the areas of Missions, Religions, and Practical Theology, in the Faculty of Theology. He has taught, researched, and published in the areas of Theology, Missions, Religions, and Inter-Faith Relations. He is a minister of the Africa Evangelical Presbyterian Church, Kenya, and Moderator of the Central Presbytery. Dr. Mutei is also attached as the senior Pastor at CPC Madaraka, Nairobi. Dr. Mutei is married to Phoebe and they are blessed with two grown children.

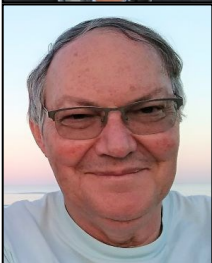

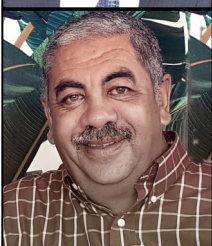
